1. A copy of your Course Curriculum – this must have a minimum of 120 hours (6 hours each day not including breaks). In addition to the 120 hours, field work, course work and home study must be undertaken.

Private teaching can qualify for a number of reduced hours

Online courses and online work are not currently accepted

A certain number of cam to cam personal teaching i.e. Skype can be accepted but must be documented.
